

ALLIANCE FOR HOUSING MEMBERSHIP AGREEMENT

The Alliance for Housing is a non-profit charitable organization with a mission to support housing solutions by promoting community partnerships. Its purpose is to establish a collective response that addresses homelessness and affordable housing in our community, to develop a local system that identifies gaps in homeless services and creates solutions to overcome these barriers and to end homelessness in our community by linking people in need with the services they require and by promoting affordable housing.

Membership in the Alliance for Housing is open to any person or organization whose purpose aligns with that of the Alliance, as stated above. The Alliance for Housing is committed to its membership through respectful, meaningful and inclusive engagement. To that end, the following defines the manner in which the Alliance for Housing and its members and member organizations will interact with one another:

The Alliance for Housing agrees to:

- Conduct ourselves in a professional, responsible, ethical and lawful manner
- Notify member organizations when there is feedback provided from the community regarding their services
- Ensure members are aware of programs and services available to support their individuals and organizations
- Conduct and share research based on statistical and evaluative information
- Ensure its programs and services are relevant to current homelessness and affordable housing needs by staying informed of emerging trends, gaps in services and feedback from our members
- Comply with the Alliance for Housing Articles of Incorporation, By-Laws, Conflict of Interest and Internal Dispute Resolution Policies

The member or member organization agrees to:

- Adopt the Mission and Purpose of the Alliance for Housing
- Provide any available statistical and evaluative information on homelessness and affordable housing within the organization to support the sector in better understanding opportunities and emerging trends in these areas
- Provide feedback that can assist in improving the Alliance for Housing
- Conduct themselves in a professional, responsible, ethical and lawful manner
- Comply with the Alliance for Housing Articles of Incorporation, By-Laws, Conflict of Interest and Internal Dispute Resolution Policies
- Pay the Alliance for Housing membership fee on an annual basis in an amount determined by the Board of Directors.

Terms:

By signing this agreement, the Alliance for Housing and the member or member organization confirms their intent to work together cooperatively under the stated conditions in this document as long as the membership is active.

Further, by signing, the member or member organization certifies that they have read and subscribe to the Alliance for Housing Articles of Incorporation, By-Laws, Conflict of Interest and Internal Dispute Resolution Policies and accept the obligation to abide by the provisions of these documents and acknowledge that a violation may result in the loss of membership.
