- Full CoC renewal application and new funding application has been submitted for over \$8 million to support RRH, PSH, Transitional Housing, HMIS, and planning grant funds
- Shelter Diversion
 - Submitted for small grant for shelter diversion funds to start January 1



- Seasonal Shelter Overflow
 - Oakland County funds will support 5 agencies to provide emergency winter shelter overflow.
- PIT
 - Point in Time count is a HUD mandated event to count homeless individuals in January each year

- Alliance Committee Summary Reports Group reviewed
- Agency Funding Spending Updates:
 - No updates available
- Chronic Numbers & Veteran Numbers presented by Holly Gauthier
 - o August 1, 2024 October 31, 2024:
 - Total Disposition Referrals: 171 (366 active)
 - 52 chronic, 24 non-chronic 12+ months, 290 other
 - HMIS Breakdown: 25 housed
 - 12 in Permanent Supportive Housing, 12 in Rapid Re-Housing, and 1
 Other Self Resolved
 - Veteran BNL Breakdown: 20 total referrals (32 active)
 - 9 housed, 1 deactivated
- Veteran Updates Presented by Monisha Scott
 - Homeless Encampments
 - Supreme court rule 6-3 that cities can ban sleeping and camping in public spaces. Overturned lower court rulings that deemed it cruel and unusual under the eight amendment to punish people for sleeping outside if they have no place to go
 - What does this mean?
 - Encampments swept and individuals ticketed. Repeated offenses can be jailed in some cities
 - More enforcement power for cities that grapple with record high rates of homelessness
 - Can influence homelessness policy in cities around the country
 - VA's Strategic Plan
 - VA, through the Homeless Program Office (HPO), is implementing a comprehensive and proactive plan to support Veterans impacted by current and future encampments closures. Concretely, this plan aims to support unsheltered Veterans living in encampments



- VA Fiscal Year Goals
 - VA has made the commitment to permanently house at least 41,000 unique Veterans nationwide in FY 2024. Detroit VA specific goals for our communities:
 - House 384 Veterans (Goal reached, housed 458, 119.3%)
 - Have less than 5% of Veterans return to homelessness or on the path to being rehoused (Goal reached 2.8% during FY)
 - Outreach 304 unsheltered Veterans (Goal reached, outreached 422, 138.8%)
